Personal data that we process

Stichting Healey Museum processes your personal data because you use our services and / or because you have provided them to us by yourself.

Below you will find an overview of the personal data that we process:

- First- and surname
- Adress
- Phone number
- Emailadress
- We record a number of data in log files. This includes: The requested address of the page, your IP number, your browser type and browser version. These data are necessary for establishing the connection between your browser and the website and are automatically sent by your browser to the website. In addition, this data is used by the operators of our website to protect it against cyber-attacks. The data are kept for seven days.

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age, unless they have permission from parents or guardians. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us via info@healeymuseum.nl , and we will delete this information.

Third parties we work with

If you use our webshop, the payments will be processed by a third party, in this case Mollie.

For what purpose and on what basis we process personal data

Stichting Healey Museum processes your personal data for the following purposes:

- To process your payment
- To be able to call or e-mail you if this is necessary to be able to perform our services
- To inform you about changes to our services and products
- To offer you the opportunity to create an account
- To deliver goods and services to you

How long we store personal data

Stichting Healey Museum does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data:

- The log files are stored for 7 days.
- The data for googleanalytics is stored for 2 years.
- The webshop data must comply with the same regulations from our tax obligations and will be stored for 7 years.

Sharing personal data with third parties

Stichting Healey Museum does not sell your information to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data on our behalf, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Stichting Healey Museum remains responsible for these processing operations.

Viewing, correcting or deleting personal data

You have the right to view, correct or delete your personal data. You can do this yourself via the personal settings of your account. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our foundation and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have about you in a computer file to you or another organization mentioned by you. If you wish to exercise your right to object and/or to data portability or if you have other

questions/comments about the data processing, please send a specified request to info@healeymuseum.nl.

To ensure that the request for access has been made by you, we ask you to send a copy of your proof of identity with the request. In this copy, make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and personal number (In The Netherlands : your Citizen Service Number - BSN) black. This is to protect your privacy. Stichting Healey Museum will respond to your request as soon as possible, but in any case within four weeks.

Stichting Healey Museum would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Autoriteit Persoonsgegevens (Dutch Data Protection Authority). This can be done via the following link:
